COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFP No. 2022-168, Annual Contract for Structured Cabling Materials and Services, for the second and final optional twelve (12) month period at the same contract terms.

BACKGROUND

On August 30, 2022, the Commissioners Court, through Court Order #138971, awarded RFP No. 2022-168, Annual Contract for Structured Cabling Materials and Services, for Information Technology, to ABLe Communications, Inc.

The award was based upon evaluation criteria set forth in the RFP specifications and contained options to renew for two (2) additional twelve (12) month periods.

On August 15, 2023, the Commissioners Court, through Court Order #141499, approved the first renewal option.

This contract is used for the purchase of data communications cabling and equipment throughout County buildings. All orders on this contract are initiated via Information Technology service requests or facility project requirements. These orders are primarily for one-time projects; however, the contract is also used for simple moves, additions, and changes within a County department for office relocations and redesign work.

The materials and equipment purchased under this contract include copper and fiber optic cabling, as well as communications storage and mounting equipment such as racks and network panels. All work is coordinated and scoped by Information Technology with review and acceptance of work prior to work beginning. All County buildings as well as any leased space obtained by the County is within the scope of this contract.

The vendor notified Purchasing in writing that they will extend the same contract terms through October 13, 2025. Information Technology notified Purchasing in writing that they are pleased with the vendor and want to renew.
