**RESOURCE CONNECTION
LEASE AGREEMENT AMENDMENT NO. 4
TARRANT COUNTY HOSPITAL DISTRICT**

BY THIS AMENDMENT NO. 4, Court Order 131169, dated the 24th day of September, 2019, by and between Tarrant County, hereinafter referred to as LESSOR, and Tarrant County Hospital District, hereinafter referred to as LESSEE, is hereby amended and supplemented in the following respects:

1. EXHIBIT "D," - RENTAL RATES

Effective October 1, 2024, Tenant shall pay Rent at an annual rate of Eight and 08/100 Dollars (\$8.08) per square foot of Combined USP (46,798 sq ft), Common Area Expense at a rate of One and 57/100 Dollars (\$1.57) per square foot of Combined USP, and Trash compaction and disposal at the annual rate of \$0.10 per square foot of Combined USP. An additional charge for trash compaction and disposal at the premises will be \$100.00 per month for each building (1400 Building and the 2500 Building). Trash collection at the premises will occur three (3) instances per week.

As to Tenant's occupancy at the 1400 Building, Tenant shall pay Utilities at the annual rate of Three and 85/100 Dollars (\$3.85) per Tenant USP (10,540sqft) of occupied space at the 1400 Building. As to Tenant's occupancy at the 2500 Building, Tenant shall pay utilities infrastructure at a rate of \$0.50 per Tenant USP (36,258sqft) and the actual utility used, minus nine percent (9%) of the total amount of utilities used at 2500 Circle Dr. to account for nine percent of the building the tenant vacated April 30, 2024.

The Utilities, Common Area Expenses and Trash compaction and disposal rates charged to Tenant hereunder shall be subject to annual, but no more than annual, reasonable changes to reimburse County for its actual costs to provide such services according to standard industry practices.

Compliance with Laws. In providing the services required by this Agreement, Vendor must observe and comply with all applicable federal, state, and local statutes, ordinances, rules, and regulations, including, without limitation, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, and non-discrimination laws and regulations. Vendor shall be responsible for ensuring its compliance with any laws and regulations applicable to its business, including maintaining any necessary licenses and permits.

Tarrant County Hospital District acknowledges that it is a "governmental entity" and not a "business entity" as those terms are defined in Tex. Gov't Code§ 2252.908, and therefore, no Form 1295 disclosure of interested parties pursuant to Tex. Gov't Code Section 2252.908 is required.

FISCAL FUNDING ACKNOWLEDGMENT

Notwithstanding any language to the contrary, Tenant acknowledges TARRANT COUNTY is a governmental entity and agrees TARRANT COUNTY may terminate this Agreement for future fiscal years if sufficient funding is not appropriated or allocated.

Both parties are in agreement as to the above. All other provisions of the above mentioned Lease Agreement remain in full force and effect. This Amendment is effective upon execution of **this** addendum.



RENTAL RATE

Effective October 1, 2024, Tenant shall pay Rent at an annual rate of Eight and 08/100 Dollars (\$8.08) per square foot of Combined USF (46,798 sq ft), Common Area Expense at a rate of One and 57/100 Dollars (\$1.57) per square foot of Combined USF, and Trash compaction and disposal at the annual rate of \$0.10 per square foot of Combined USF.
