**SUBJECT: APPROVAL OF FUNDING FOR THE FISCAL YEAR 2025
CONTRACT RENEWAL BETWEEN TARRANT COUNTY AND MY
HEALTH MY RESOURCES OF TARRANT COUNTY FOR THE
PROVISION OF CLINICAL MANAGEMENT FOR BEHAVIORAL
HEALTH SERVICES DRUG ASSESSMENT SERVICES**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve funding for the FY 2025 contract renewal between Tarrant County and My Health My Resources of Tarrant County (MHMRTC) for the provision of Clinical Management for Behavioral Health Services (CMBHS) drug assessment services.

BACKGROUND

MHMRTC is the second-largest community center in Texas and provides services related to mental health, intellectual and developmental disabilities, addiction and substance use, child and family services, early childhood intervention, criminal justice support and veterans' homelessness. MHMRTC is comprised of clinical and administrative professionals, including nurses, social workers, therapists and case managers who provide services at more than fifty (50) locations across North Texas. These services are provided with partners in the public and private sector.

On August 15, 2023, the Commissioners Court, through Court Order #141472, approved the FY 2024 contract renewal with MHMRTC for the provision of CMBHS drug assessment services, including a Licenced Chemical Dependency Counselor Assessment Coordinator to provide drug and alcohol assessments at various satellite locations. The term of this contract is October 1, 2023 through September 30, 2024, in an amount not to exceed \$30,000.00.

With approval, MHMRTC will continue to provide CMBHS drug assessment services for the term of October 1, 2024 through September 30, 2025, in an amount not to exceed \$30,000.00.

This contract has been reviewed as to form by the Criminal District Attorney's Office and approved by the Tarrant County Juvenile Board at the July 17, 2024 board meeting.

FISCAL IMPACT

Funding of \$24,700.00 is provided in 10000-2025 General Fund / 2610210000 Juvenile Services Traditional Supervision / 569011 Professional Services and \$5,300.00 in P0111-2025 Texas Juvenile Justice Department State Aid – Youth Services / 2610210000 Juvenile Services Traditional Supervision / 569011 Professional Services.
