PARTIES TO CONTRACT

Tarrant County ("County") and My Health My Resources of Tarrant County ("Service Provider") agree to the following terms and conditions of this contract Amendment No. 1.

CONTRACT TERMS AMENDED:

10. PAYMENT OF REIMBURSABLE COSTS

10.1 The total amount reimbursable due under this contract during September 1, 2023 through August 31, 2024 will not exceed \$52,072.80. (\$40,072.80 CYD and \$12,000.00 CBCAP ARPA)

Department of Family and Protective Services is partially funding this award under US Department of Health and Human Services Administration for Children and Families Community-Based Child Abuse Prevention (CBCAP) under the statutory authority of the American Rescue Plan Act (ARPA).

This one-time funding available through the federal American Rescue Plan Act (ARPA) allocation for Community Based Child Abuse Prevention grantees will be used for one-time program costs, including investments in emergency basic needs assistance for families served in the Community Youth Development program.
