AMENDMENT NO. ONE - INTERLOCAL AGREEMENT  
BETWEEN TARRANT COUNTY AND THE CITY OF  
MANSFIELD

AMENDMENT NO. ONE

**WHEREAS**, on September 5, 2023 through Court Order No. 141679, **Tarrant County, Texas** ("**COUNTY**") and **City of Mansfield** ("**CITY**"), entered into an Interlocal Agreement ("**AGREEMENT**") where the **CITY** is requesting the **COUNTY's** assistance to reconstruct Country Meadow Drive ("**PROJECT**"); and

**WHEREAS**, the **PROJECT** is located within Tarrant County Precinct 2 and the municipal limits of the City of Mansfield; and

**WHEREAS**, since the original **AGREEMENT** was adopted, a need has been identified by the **CITY** for the **COUNTY** to assist with culvert work, and the **COUNTY** has the capacity to assist;

**NOW, THEREFORE**, the **COUNTY** and **CITY**, hereby agree to the following Amendment No. One to the said **AGREEMENT**:

1. **COUNTY** and **CITY** agree to **add** under Terms and Conditions, the following items under Section 1. County Responsibility and Section 2. City Responsibility:

**1. COUNTY RESPONSIBILITY**

- 1.8 Replace culverts currently identified by **CITY** as being defective; and
- 1.9 Provide base material need for culvert replacement.

**2. CITY RESPONSIBILITY**

- 2.11 **CITY** will provide culverts and #4 rock;
- 2.12 **CITY** will close Country Meadow Drive to all traffic during culvert replacement; and
- 2.13 **CITY** will provide all appropriate notifications, signage, and traffic control for the road closure.

2. **COUNTY** and **CITY** also agree to extend the Termination of Agreement in Section 10 from May, 31, 2024 to December 31, 2025;
3. All other conditions and requirements of said **AGREEMENT** remain the same, unless amended in writing and agreed upon by both parties.
