Re: Auditor's Report - FY2023 Chapter 59 Asset Forfeiture Report by Law Enforcement Agency

As required by Chapter 59 of the Code of Criminal Procedure, the Auditor's Office reviewed the FY2023 *Chapter 59 Asset Forfeiture Report by Law Enforcement Agency* prepared by the Tarrant County Sheriff's Office. During FY2023, revenues from forfeiture funds, auction proceeds, and interest totaled \$418,195.15. Expenditures using state forfeiture funds totaled \$261,592.84. We determined that the amounts presented in the report were reasonable. We also discussed less significant items identified with management during our review. The report was electronically signed and submitted to the Office of the Attorney General on time.

The Sheriff's Office reports financial and non-financial case activities to the Criminal District Attorney (CDA). The CDA's Office records case activities into the Time Matters database. Due to the volume of Chapter 59 seizures and forfeitures it is not possible for the auditor to inspect *all* relevant documents and supporting materials. The annual report focuses on two separate elements of the asset forfeiture process: financial activity and case activity.

1. Financial Activity: Sections I and II include monies under the control and custody of the Sheriff's Office. We reviewed selected cash transactions recorded in the database to supporting documents such as court orders, seizure reports, and receipts. We also traced cash transactions under the control of the Sheriff's Office to the County's general ledger without exception. Section VI includes expenditures made by the Tarrant County Sheriff's Office for activities related to the preservation, enforcement, and the administration of state law. We reconciled the amounts included on the report to the County's general ledger without exception.
2. Case Activity: Sections III, IV, and V of the report include non-cash assets, such as motor vehicles, firearms, and other property (i.e., TV's, PC's, etc.). On a test basis, we 1) traced the non-cash assets recorded in the Time Matters database to supporting documentation such as court orders and auction sales reports, and 2) performed a physical inspection of the assets under the control of the Tarrant County Sheriff's Office without exception.

We appreciate the cooperation of the Tarrant County Sheriff's Office staff during the review. If you have any questions, please do not hesitate to call.


