## **BACKGROUND**

On April 12, 2022, the Commissioners Court, through Court Order #137921 awarded RFP No. 2022-088, Annual Contract for Offender/Defendant-Paid DWI Education, DWI Repeat Offender Program, and Drug Offender Education Program, for Community Supervision and Corrections Department (CSCD), to the following vendors:

On January 10, 2023, the Commissioners Court, through Court Order #140084, approved the first renewal option.

North Texas Addiction Counseling and Education, Inc. has failed to comply with contract terms by not immediately notifying CSCD of an employee arrest during the term of the contract or forwarding the names of new employees to CSCD for the purpose of a criminal background investigation and acceptance.

On November 10, 2023, CSCD provided the vendor a thirty (30) day notice of contract termination, effective December 10, 2023

In a response dated November 14, 2023, the vendor acknowledged the contract termination.

Therefore, it is the joint recommendation of CSCD and Purchasing that the Commissioners Court cancel the award made to North Texas Addiction Counseling and Education, Inc. for RFP No. 2022-088, Annual Contract for Offender/Defendant-Paid DWI Education, DWI Repeat Offender Program, and Drug Offender Education Program.

### **FISCAL IMPACT**

Services are paid for by defendants and are provided on an as-needed basis. No Tarrant County funds have been paid.
