

Dear Cathy Halliburton,

I, AZTECA Designs Inc. (the "Contractor"), am writing to formally request a project extension to the date of September 6, 2024, due to the reasons stated below.

- ****Carpet Delay****: Carpet delay until last week of July per manufacturer, no firm date was given by mil, AZTECA will follow up with mil to Monday July 8th as the mil is closed all this week. AZTECA has requested this order to be expedited but no firm date was given.
- ****Millwork Approval and Production****: Our initial millwork company estimated the first batch would be ready by late June and the remainder by mid-July. However, they recently informed us that they would not be able to fulfill the order in a timely manner. AZTECA promptly terminated their contract and secured a new millwork company. The new company will begin production on July 9th and will have the first batch delivered on July 15th and installed that week. The second batch will be delivered and installed the week of July 22nd. With the final submittal for the millwork
- ****Glass Delivery****: The glass for the project will not be delivered until August 9th, with installation scheduled for August 12th-19th. Please see the attached email for further details.
