**SUBJECT: BID NO. F2024150 - ANNUAL CONTRACT FOR TRASH REMOVAL SERVICES - FACILITIES MANAGEMENT - VARIOUS VENDORS - PER UNIT PRICE, HOURLY RATE, AND MARKUP FOR PARTS**

## **COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court award Bid No. F2024150, Annual Contract for Trash Removal Services, for Facilities Management, to the following vendors at the per unit price, hourly rate, and markup for parts:

Primary	Republic Services d/b/a Allied Waste Services of Texas
Secondary	TJ Ranches, LLC d/b/a TJ Services
Alternate	Frontier Access, LLC d/b/a Frontier Waste Solutions

## **BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred seventy-six (176) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on June 17, 2024 was attended by five (5) vendors as well as representatives from Facilities Management and Purchasing. Three (3) bids were received.

Bids were evaluated by Facilities Management and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The term of the contract is twelve (12) months, effective October 1, 2024, with two (2) options for renewal periods of twelve (12) months each.

The purpose of this contract is for trash removal services for Tarrant County locations. Container size, scheduled trash removal services, and trash compactor equipment rental and repair will be established as needed.

Therefore, it is the joint recommendation of Facilities Management and Purchasing that Bid No. F2024150, Annual Contract for Trash Removal Services, be awarded to the vendors listed above at the per unit price, hourly rate, and markup for parts.
