**SUBJECT: BID NO. F2024187 - MARKUM RANCH ROAD WIDENING
PROJECT - TRANSPORTATION SERVICES - JACKSON
CONSTRUCTION, LTD.**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2024187, Markum Ranch Road Widening Project, for Transportation Services, to Jackson Construction, Ltd. for \$2,513,237.00, approve contract and accept bonds.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Five hundred four (504) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on August 19, 2024 was attended by two (2) vendors as well as representative from Pacheco Koch a Westwood Company, Transportation Services, and Purchasing. Three (3) bids and two (2) no-bids were received.

The bid received from Jackson Construction, Ltd. meets all specifications and is acceptable to Transportation Services.

The purpose of this bid is to widen and reconstruct Markum Ranch Road from the I-20 eastbound frontage road southward to Ranchers Legacy Trail.

Therefore, it is the joint recommendation of Pacheco Koch a Westwood Company, Transportation Services, and Purchasing, that Bid No. F2024187, Markum Ranch Road Widening Project, be awarded to Jackson Construction, Ltd. for \$2,513,237.00.

The contract is attached for approval and signature. The CDA's Office reviewed this contract as to form.
