### **COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court award RFP No. F2024018, Annual Contract for Personal Financial Statement Software Subscription, for the County Clerk's Office, to EasyVote Solutions, Inc. and approve contract.

### **BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred forty-three (343) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on October 25, 2023 was attended by one (1) vendor as well as representatives from the County Clerk's Office, Elections Administration, Information Technology and Purchasing. One (1) proposal and four (4) no-bids were received.

The proposal was evaluated by the County Clerk's Office, Elections Administration, Information Technology and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP.

The vendor was invited to provide a demonstration on January 4, 2024. A Best and Final Offer was then requested from the vendor which resulted in a 0.78% reduction in total price. The proposal received from EasyVote Solutions, Inc. meets all specifications and is acceptable to the County Clerk's Office and Information Technology.

The term of the contract is twelve (12) months, effective April 2, 2024, with two (2) options for renewal periods of twelve (12) months each.

This software solution is for managing and tracking financial statements provided by local elected officials and candidates as required under Chapter 159, Texas Local Government Code.
