**SUBJECT: CONSIDERATION OF CONSOLIDATION OF NINE INTERLOCAL AGREEMENTS WITH THE CITY OF RIVER OAKS RELATED TO THE RESIDENTIAL STREETS RECONSTRUCTION PROJECT - 2021 TRANSPORTATION BOND PROGRAM**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court consider consolidation of nine Interlocal Agreements with the City of River Oaks related to the Residential Streets Reconstruction project – 2021 Transportation Bond Program (TBP), Call for Projects (CFP) funding category, located in Precinct 4.

**BACKGROUND**

On August 3, 2021, the Commissioners Court, through Court Order #136021, approved a prioritized list of thirty-three (33) projects recommended by the participating cities and the Court-appointed Project Evaluation Committee (PEC) for funding in the Call for Projects category of the 2021 TBP.

On June 6, 2023, the Commissioners Court, through Court Order #141058, approved Amendment No.1 to the 2021 TBP – CFP for the City of River Oaks, Residential Streets for funding in the amount of \$1,417,465.00.

On June 18, 2023, the Commissioners Court, through Court Order #141326, approved Amendment No.2 to the 2021 TBP – CFP for the City of River Oaks, Residential Streets for funding in the amount of \$1,417,285.50.

On July 18, 2023 and on October 17, 2023, the Commissioners Court, approved all nine (9) ILAs with the City of River Oaks for the projects as listed in Attachment “A”. The Court Order numbers are also provided in Attachment “A”.

The County and the City of River Oaks would like to combine all the referenced projects in to one (1) consolidated ILA with total funding in the amount of \$1,417,285.50 from the 2021 TBP-CFP funding category.

With approval, this will consolidate nine (9) separate ILAs with the City of River Oaks in to one (1) consolidated ILA with total funding in the amount of \$1,417,285.50 from the 2021 TBP-CFP funding category.

This consolidation ILA has been reviewed by the Auditor's Office and approved as to form by the Criminal District Attorney's Office.
