COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2024025, Annual Contract for Tires and Tubes for Vehicles and Equipment, Countywide, to the following vendors at the per unit price and discount from list price:

Primary	Southern Tire Mart, LLC
Secondary	Car Concepts Commercial, LLC d/b/a Blagg Tire Wholesale
Alternate	Conlan Tire Co. LLC d/b/a Sidewall Holdings LLC

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred seven (207) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on November 27, 2023 was attended by one (1) vendor as well as representatives from Transportation Services and Purchasing. Four (4) bids were received.

Bids were evaluated by Transportation Services, the four (4) Maintenance Precincts, and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The term of the contract is twelve (12) months, effective March 13, 2024, with two (2) options for a renewal period of twelve (12) months each.

This contract is for the purchase of tires and tubes for vehicles and equipment.

Therefore, it is the joint recommendation of Transportation Services, the four (4) Maintenance Precincts, and Purchasing that Bid No. F2024025, Annual Contract for Tires and Tubes for Vehicles and Equipment, be awarded to the vendors listed above at the per unit price and discount from list price.
