**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court consider the FY 2024-2025 Texas Department of State Health Services (DSHS) HIV/Services (State Services) subrecipient contract renewal with Tarrant County Preventive Medicine Clinic (PMC).

**BACKGROUND**

Tarrant County receives annual funding from DSHS in the form of grant contracts. The Texas DSHS State Services grant will continue to fund health insurance, transportation, and referral for health care and support services in the Fort Worth Health Service Delivery Area (HSDA).

PMC has been delivering HIV services for more than twenty-five (25) years and is an HIV medical clinic that is part of Tarrant County Public Health (TCPH). PMC delivers a variety of services to people living with HIV in Tarrant County and surrounding areas. This contract supports Referral for Health Care and Support Services.

On May 21, 2024, the Commissioners Court, through Court Order #143143, approved the FY 2024-2025 Texas DSHS State Services grant contract renewal in the amount of \$1,094,360.00.

The project period for DSHS State Services grant is September 1, 2023 through August 31, 2025. The term of the budget period is September 1, 2024 through August 31, 2025.

The recommended contract renewals are as follows:

PMC – Total reimbursement shall not exceed \$112,100.00.
