AMENDMENT NO. 1

WHEREAS, on May 18,2021 (Court Order No. 135481), the Tarrant County Commissioners Court ("COUNTY") approved an engineering contract ("Contract") with Summit Consultants, Inc., ("PROVIDER") for the Plaza Building Chiller Replacement project, 200 Taylor Street, Fort Worth.

NOW, THEREFORE, the COUNTY and PROVIDER hereby agree to the following Amendment No. 1 to the Agreement, for additional engineering services by Summit Consultants, Inc. as requested by the owner during the design phase of the project. Amendment No. 1 reflects the additional service compensation to cover work described within this proposal, said renovations to be defined by COUNTY and mutually agreed to by PROVIDER. The proposal dated January 16, 2024, from PROVIDER, shown in Exhibit "A" and this Professional Services Contract, forms the contract between the parties.

COMPLIANCE WITH LAWS.

In providing the services required by this Agreement, PROVIDER must observe and comply with all applicable federal, state, and local statutes, ordinances, rules, and regulations, including, without limitation, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, and non-discrimination laws and regulations. PROVIDER shall be responsible for ensuring its compliance with any laws and regulations applicable to its business, including maintaining any necessary licenses and permits.

The Services to be provided by the PROVIDER as outlined more specifically in Exhibit "A" shall include, but are not limited to, the following:

Additional Services

Tarrant County requested the add alternate of replacing all the condenser water piping be removed from the project. Summit will revise the drawings to remove add alternates from the project to aide in the bidding process. Summit will reassemble the drawings/specifications and provide Tarrant County with an updated digital PDF set for rebidding. These additional services are as a result of the rejection of bidders during the first round of bidding at the end of 2022.

The COUNTY will pay no more than \$10,600.00 for these additional services as further described in the attached proposal incorporated into this Amendment as Exhibit "A".


All other conditions and requirements of said Agreement remain in full force and effect for the duration of the Agreement period, unless amended in writing and agreed upon by both parties.



Mr. Shephard:

Summit Consultants, Inc. (Summit) is pleased to offer the following additional services for the Tarrant County Plaza Building Chiller Replacement project.

ADDITIONAL SERVICES:

Tarrant County requested the add alternate of the EZ Water System be added to the base bid of the project in lieu of being an add alternate. Tarrant County requested the add alternate of replacing all of the condenser water piping be removed from the project. Summit will revise the drawings to remove add alternates from the project to aide in the bidding process. Summit will reassemble the drawings/specifications and provide Tarrant County with an updated digital PDF set for rebidding. For the second round of bidding for the Tarrant County Plaza Building Chiller Replacement project, Summit will participate in the pre-bid meetings, pre-bid site visit, bidding review, and tabulation process. These additional services are as a result of the rejection of bidders during the first round of bidding at the end of 2022. The rejection of bidders was due to the bidders not submitting equipment that met the specifications. The existing basic services of the original contract shall remain intact and should continue once the second round of bidding is finished and construction administration services begins.

Summit Consultants, Inc. will be paid \$10,600 for the additional services stated above. Summit's original contracted amount is \$75,200 (includes \$200 reimbursable expenses). Summit's contract will need to be updated to \$85,800 for the additional services. Below is a breakout of the original contract expenses and the additional services.
