1. ***Digital scans of scrapbook, donated by Philip Elliott Schwab (2024-012-563)***  
Scrapbook documents a year in the life of the donor's grandmother, Kathleen Schwab, who hosted a public access television show in Missouri. Kathleen Schwab, nee Carter, was born and grew up in Dallas and attended Texas Woman's College. Her husband's work moved her family around the country, but she maintained connections to Texas through relatives. The scrapbook contains a short biography, news clippings, photos, correspondence, and other ephemera related to Schwab's life and work.
2. ***Two (2) copies of Footprints, donated by the Fort Worth Genealogical Society (2024-013-179; 2024-023-179)***  
The Fort Worth Genealogical Society publishes the *Footprints* journal quarterly. *Footprints* contains genealogical research related to Tarrant County families, and supporting documentation such as church, cemetery, and school records, newspaper clippings, and more. The Tarrant County Archives holds a full run of the *Footprints* journal, and the Fort Worth Genealogical Society continues to donate new issues to the collection.
3. ***Collection of materials related to theater in Fort Worth, donated by C. Kevin Starnes (2024-14-745)***  
Materials donated are all related to the production of *The Littlest Wiseman*, a production of the William Edrington Scott Theater in Fort Worth. Materials include programs, a letter to the cast, newspaper article, and Starnes' research about the play. *The Littlest Wiseman* played at the Scott Theater from 1966, the year of the theater's opening, through 2019.
4. ***Tarrant County images, donated by the Tarrant County Administrator's Office (2024-016-171; 2024-019-171)***  
Materials donated include photo prints, posters, and one (1) drawing depicting Tarrant County buildings and events. These images are not otherwise represented within the collections and show interesting County graphic design.
5. ***Collection of materials related to the Halbower family and Fort Worth theatre history, donated by Rebecca and Susan Halbower (2024-017-025)***  
Donated materials are to be added to an existing collection from the Halbower family which relates to early Fort Worth theatre history, the Fort Worth Cats, and various other topics. Like the previous donation, this new donation was collected by the donors' uncle Julian Umbenhour, and materials are primarily theatre related, like sheet music, programs, publications, and Edison record cylinders. The donation also contains many ledgers from the Halbower family business based in Fort Worth.
6. ***Materials related to Tarrant County events, donated by the Tarrant County Human Resources Department (2024-018-286)***  
Donated materials include photographs, handbooks, documents, and newsletters concerning Tarrant County fundraisers and events dating from 1979 to 2019. Some photographs are digital.

**7. *Local newspapers, donated by the White Settlement Historical Museum (2024-020-083; 2024-022-083; 2024-028-083; 2024-029-083)***

The White Settlement Historical Museum had a collection of hundreds of newspapers, from the Suburban Publishing Company, related to White Settlement and other areas of Tarrant County. The Museum kept two (2) copies each of White Settlement related papers and donated the extra copies, along with all copies of papers from Fort Worth, Benbrook, Azle, and various other municipalities, neighborhoods, and townships. These newspapers often contain local news that is not otherwise documented.

**8. *Four (4) items, donated by the Dell DeHay Law Library of Tarrant County (2024-021-074)***

Materials donated include a program, booklet, and challenge coin from the 2024 dedication of the Tarrant County Law Enforcement Memorial. Additionally, a copy of the Texas Library Association Conference newsletter was included in this donation.

**9. *Digital photographs of Nurse's Aide Corps materials, donated by Michael McClary (2024-024-088)***

Materials donated are digital photographs of original documents and objects related to the Tarrant County Chapter of the American Red Cross Nurse's Aide Corps. These materials include a nurse's exam, guidelines on bed baths, correspondence, pins, and newsletters. Materials date from the 1920s through the 1940s.

**10. *Digital photographs and photo print related to Kennedale history, donated by the Kennedale Historical Society (2024-026-033)***

Donation includes a CD with images of past Kennedale mayors, and a photo print of what is believed to be the 1939 Kennedale High School class, with a list of names identifying the individuals pictured.

**11. *Various items related to Tarrant County history, donated by Devin Pipes (2024-027-692)***

Materials donated include newspaper clippings with articles related to the history of the county, photos of various notable buildings in the county, a Fort Worth sesquicentennial calendar with historic photos and information, and a 2022 Arlington visitor's guide.

**12. *Digital materials related to the history of Alcon Laboratories, donated by Tom McDonald (2024-030-292)***

Donation includes one flash drive containing thousands of documents, photographs, and other materials gathered during Tom McDonald's research for his book covering the first 50 years of Alcon Laboratories. Alcon is a major scientific and medical company focused on eye health and creating technologies to better care for eyes. Alcon was founded in 1945 in Fort Worth, which remains the headquarters for the company today.
