COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFQ No. 2022-070, Mental Health Service Providers, for the second and final optional twelve (12) month period at the same contract terms.

BACKGROUND

On April 26, 2022, the Commissioners Court, through Court Order #137996, awarded RFQ No. 2022-070, Mental Health Service Providers, for Public Health, to the following vendors:

Bridges to Crossroads Counseling & IOP Care
PSP Professional Services, Inc.

The awards were based upon the evaluation criteria set forth in the RFQ specifications and contained options to renew for two (2) additional twelve (12) month periods.

On February 21, 2023, the Commissioners Court, through Court Order #140326, approved the first renewal option.

The Tarrant County Public Health Department's (TCPH) Preventative Medicine Clinic (PMC) offers primary care and case management for adults living with HIV. As part of this management, psychological, diagnostic and therapeutic services are sometimes needed and allowable under the Health Resources and Services Administration (HRSA) Ryan White HIV/AIDS Program. Services must be provided by mental health practitioners licensed to practice in the State of Texas.

The vendors notified Purchasing in writing that they will extend the same contract terms through April 25, 2025. Public Health notified Purchasing in writing that they are pleased with the vendors and want to renew.

Therefore, it is the joint recommendation of Public Health and Purchasing that the Commissioners Court approve renewal of RFQ No. 2022-070, Mental Health Service Providers, for another twelve (12) month period.
