It is requested that the Commissioners Court accept payment and performance bonds for Bid No. 2023-010, Annual Contract for Irrigation Supplies, Services, and Repairs, Countywide, from Greycon, Inc. d/b/a Grey Construction for \$357,400.00.

BACKGROUND

On November 22, 2022, the Commissioners Court, through Court Order #139765, awarded Bid No. 2023-010, Annual Contract for Irrigation Supplies, Services, and Repairs, to the following vendors:

Secondary	MG Lawn and Landscape, LLC
Primary	C. Green Scaping, LP

On October 3, 2023, the Commissioners Court, through Court Order #141890, approved the first renewal option.

The quote received from Greycon, Inc. d/b/a Grey Construction meets all requirements and is acceptable to Facilities Management. Greycon, Inc d/b/a Grey Construction will provide all labor, materials, and equipment for the installation of new irrigation systems.
