HEALTH RESOURCES AND SERVICES ADMINISTRATION RYAN
WHITE PART C NOTICE OF AWARD**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve Amendment No. 3 to the FY 2024 Health Resources and Services Administration (HRSA) Ryan White Part C (Part C) Notice of Award (NOA) in the amount of \$14,051.00.

BACKGROUND

Tarrant County receives annual grant funding from HRSA to provide a variety of essential core and support services to HIV-positive individuals. Part C grant funding provides health care and support services in outpatient settings for people living with HIV in the Health Services Delivery Area (HSDA). HSDA includes the Fort Worth/Arlington Transitional Grant Area (TGA) which includes the counties of Tarrant, Wise, Johnson, Parker, Hood, Erath, Palo Pinto, and Somervell. Tarrant County HIV Administrative Agency (HIV AA) administers grant funding through subcontracts with community organizations that deliver high-quality HIV services.

On December 19, 2023, the Commissioners Court, through Court Order #142299, approved the partial FY 2024 HRSA NOA for the Part C contract in the amount of \$215,771.00.

On February 21, 2024, the Commissioners Court, through Court Order #142660, approved Amendment No. 1 to the FY 2024 HRSA NOA for the Part C funding in the amount of \$287,696.00, increasing the total award to \$503,467.00.

On June 18, 2024, the Commissioners Court, through Court Order #143327, approved Amendment No. 2 to the FY 2024 HRSA NOA for Part C funding in the amount of \$359,617.00, increasing the total award to \$863,084.00.

With approval of Amendment No. 3 to the FY 2024 HRSA Part C NOA, supplemental funding of \$14,051.00 will be added to the Part C grant award bringing the total funding to \$877,135.00.

The project period for the HRSA FY 2024 Part C Grant is January 1, 2022 through December 31, 2024. The term of the grant contract is January 1, 2024 through December 31, 2024.
