It is requested that the Commissioners Court award Bid No. F2024046, Purchase of Self-Propelled Reclaimer Stabilizers, for Precincts 1, 2, and 3, to the following vendors at the per unit price:

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred ninety-one (191) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on December 20, 2023 was attended by three (3) vendors as well as representatives from Precincts 1, 2, 3 and Purchasing. Three (3) bids and one (1) no-bid were received.

Bids were evaluated by Precincts 1, 2, 3 and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The purchase of this is for the use of asphalt reclamation and the injection of Cem-Lime slurry for soil stabilization of County and interlocal city roads.

Therefore, it is the joint recommendation of Precincts 1, 2, 3 and Purchasing that Bid No. F2024046, Purchase of Self-Propelled Reclaimer Stabilizers, be awarded to the vendors listed above at the per unit price.
