It is requested that the Commissioners Court award Bid No. F2024101, Annual Contract for Pump and Motor Inspection, Repair, and Replacement Services, for Facilities Management, to the following vendors at the per hourly rate and markup for parts:

BACKGROUND

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Four hundred fifty-six (456) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Four (4) bids were received.

Bids were evaluated by Facilities Management and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The term of the contract is twelve (12) months, effective June 4, 2024, with two (2) options for renewal periods of twelve (12) months each.

This contract will be utilized to inspect, test, repair, or replace pumps and motors associated with HVAC, plumbing, irrigation, and domestic water systems in County buildings and grounds.

Therefore, it is the joint recommendation of Facilities Management and Purchasing that Bid No. F2024101, Annual Contract for Pump and Motor Inspection, Repair, and Replacement Services, be awarded to the vendors listed above at the per hourly rate and markup for parts.
