


FLOOR PLAN

REFLECTED CEILING PLAN




KEYED NOTES

1. REMOVE EXISTING WALL, DOOR AND FRAME AND RELOCATE DOOR AND FRAME TO NEW ADJACENT WALL. PAINT FRAME.
2. REMOVE AND RELOCATE EXISTING HORN STROBE TO NEW WALL.
3. REMOVE EXISTING DOOR ONLY. DOOR FRAME TO REMAIN IN PLACE AS IS. PAINT FRAME.
4. REMOVE AND RELOCATE EXISTING RECESSED LIGHT FIXTURE TO NEW LOCATION AS SHOWN.
5. PROVIDE NEW GYP. BD. WALL; 3 5/8" MTL. STUDS @ 16" O.C. MAX W/ 5/8" GYP. ON EACH SIDE, TAPE, BED, SAND TEXTURE AND PAINT. MATCH EXISTING FINISHES.
6. PROVIDE NEW 3'-0" X 7'-0" WOOD DOOR AND METAL FRAME TO MATCH EXISTING. (3 TOTAL)
7. BEGIN NEW WALL AT CORNEREDGE OF EXISTING WALL.
8. TERMINATE EXISTING LIGHT SWITCH AND PROVIDE NEW LIGHT SWITCH WIRED TO EXISTING AND NEW LIGHT FIXTURES AS SHOWN.
9. PROVIDE NEW CEILING MOUNTED SMOKE ALARM.
10. REMOVE AND RELOCATE EXISTING CEILING MOUNTED SMOKE ALARM AS SHOWN.
11. PATCH/REPAIR EXISTING WALL WHERE WALL WAS REMOVED. MATCH EXISTING FINISHES.
12. PROVIDE NEW LAY-IN FLUORESCENT LIGHT FIXTURE. MATCH EXISTING.
13. RELOCATED DOOR AND FRAME FROM WALL THAT WAS REMOVED.
14. EXTEND EXISTING CEILING TO NEW WALL. PROVIDE CEILING TILES AND GRID AS REQUIRED.


