**SUBJECT: APPROVAL OF AMENDMENT NO. 4 TO THE FISCAL YEAR 2022  
TEXAS DEPARTMENT OF STATE HEALTH SERVICES  
SEXUALLY TRANSMITTED DISEASE/HUMAN  
IMMUNODEFICIENCY VIRUS-DISEASE INTERVENTION  
SPECIALISTS GRANT CONTRACT**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 4 to the FY 2022 Department of State Health Services (DSHS) Sexually Transmitted Disease/Human Immunodeficiency Virus-Disease Intervention Specialists (STD/HIV-DIS) Grant Contract, #HHS001120300014.

**BACKGROUND**

The purpose of the STD/HIV-DIS grant is to control and prevent the spread of Sexually Transmitted Diseases (STDs), including Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) and viral hepatitis, through Disease Intervention Specialists (DIS). The DIS conducts partner services interviews and field investigations to notify and offer education and testing related to STDs.

On January 4, 2022, the Commissioners Court, through Court Order #137177, approved a contract for FY 2022 funding in the amount of \$526,757.00 to support the STD/HIV-DIS purpose in Tarrant County. The term of this contract was January 1, 2022 through August 31, 2022. DSHS has sole discretion to extend this Contract, provided the Contract does not exceed five years.

On March 1, 2022, the Commissioners Court, through Court Order #137567, rescinded Court Order #137177 and approved a revised contract for FY 2022 funding in the amount of \$395,067.00. The term of this contract ended August 31, 2022.

On April 12, 2022, the Commissioners Court, through Court Order #137914, approved Amendment No. 1, shifting from Fiscal Year to Calendar Year (CY) terms. CY 2022 funding increased by \$395,068.00 and the contract term was extended through December 31, 2022.

On October 18, 2022, the Commissioners Court, through Court Order #139474, approved Amendment No. 2, increasing the CY 2022 funding amount by \$640,452.00 and adding \$790,135.00 for CY 2023. The contract term extended through December 31, 2023.

On February 7, 2023, the Commissioners Court, through Court Order #140248, approved Amendment No. 3, extending the contract term for Calendar Year (CY) 2022 through January 31, 2023, and restating the CY 2023 contract term to February 1, 2023 through December 31, 2023.
