The International Association of Human Trafficking Investigators 13th Annual Conference is an advanced training facilitated by the worldwide leader in human trafficking education. Training is provided for law enforcement and prosecutors to provide innovative, practical, and trauma -informed strategies to enhance victim-centered responses and offender-focused investigations and prosecutions. Topics will include labor and sex trafficking case studies, organized crime investigations, undercover operations, analytical support, prosecution, interview and investigation breakout sessions, and gang trafficking investigations. Participants will learn how to better identify and investigate human trafficking, leverage partnerships, and work with public data and technology, in addition to networking with other professionals and leaders to establish and foster working relationships for continued collaboration.

We respectfully request approval for lead Human Trafficking Attorney, Lindy Borchardt and Investigator Rodriguez to attend the conference, which is fully funded through a grant awarded by the Office of the Governor in FY24 for the District Attorney's Human Trafficking Prosecution Unit, which provides up to \$6,000 for specialized training. 
