COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of RFP No. 2021-107, Intensive Spanish Language Mental Health Services, for the third and final optional twelve (12) month period at the same contract terms and approve contract.

BACKGROUND

On August 10, 2021, the Commissioners Court, through Court Order #136045, awarded RFP No. 2021-107, Intensive Spanish Language Mental Health Services, for Juvenile Services, to Lena Pope Home, Inc.

The award was based upon evaluation criteria set forth in the RFP specifications and contained options to renew for three (3) additional twelve (12) month periods.

On August 16, 2022, the Commissioners Court, through Court Order #138867, approved the first renewal option.

On August 29, 2023, the Commissioners Court, through Court Order #141559, approved the second renewal option.

This contract provides court-ordered community based mental health treatment services for Spanish-speaking youth and their families under the supervision of Tarrant County Juvenile Services.

The vendor notified Purchasing in writing that they will extend the same contract terms through August 31, 2025. Juvenile Services notified Purchasing in writing that they are pleased with the vendor and want to renew. The Tarrant County Juvenile Services Board approved the contract renewal on July 17, 2024.

Therefore, it is the joint recommendation of Juvenile Services, Tarrant County Juvenile Services Board, and Purchasing that the Commissioners Court approve renewal of RFP No. 2021-107, Intensive Spanish Language Mental Health Services, for another twelve (12) month period.
