As future healthcare professionals, we are taught to advocate for our patients, to speak up when we feel their rights are violated, and to consider the ethical implications of our practice beyond the hospital. I'm glad to see that these real, heartbreaking stories are finally getting the public attention they deserve, and I urge us to terminate this agreement to prevent these violations from happening again.
