COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award Bid No. F2024163, Annual Contract for Aggregate Road Surface Treatment, Countywide, to the following vendors at the per unit price and discount from list price:

Primary	CJA Enterprises LLP Vulcan Construction Materials, LLC	Sections 1, 3, 4, 5, and 6 Section 2
Secondary	P&K Stone LLC Vulcan Construction Materials, LLC	Sections 2 and 4 Sections 1, 3, 5, and 6
Alternate	Green Dream International Vulcan Construction Materials, LLC	Sections 1, 2, 3, 5, and 6 Section 4

BACKGROUND

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Three hundred forty-nine (349) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Four (4) bids were received.

Bids were evaluated by the four (4) Maintenance Precincts and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Section 4, item 4.2, was not evaluated as this item is no longer available.

The term of the contract is twelve (12) months, effective October 1, 2024, with two (2) options for renewal periods of twelve (12) months each.

The purpose of this bid is for the purchase of materials used in road construction. Aggregate road surface materials are primarily used to provide drainage and fill voids.

Therefore, it is the joint recommendation of the four (4) Maintenance Precincts and Purchasing that Bid No. F2024163, Annual Contract for Aggregate Road Surface Treatment, be awarded to the vendors listed above at the per unit price and discount from list price.

FISCAL IMPACT

Expenses for last year were approximately \$34,805.16. Orders are placed on an as-needed basis. Funding has been requested in the FY 2025 budget.
