**1. *Three (3) issues of Footprints, donated by the Fort Worth Genealogical Society (2023-037-179 & 2023-039-179)***

The Fort Worth Genealogical Society publishes the *Footprints* journal quarterly. *Footprints* contains genealogical research related to Tarrant County families, and supporting documentation such as church, cemetery, and school records, newspaper clippings, and more. The Tarrant County Archives holds a full run of the *Footprints* journal, and the Fort Worth Genealogical Society continues to donate new issues to the collection.

**2. *Selection of photographs, donated by Dalton Hoffman. (2023-047-503)***

Donated materials include about fifty (50) photographs which capture various aspects of Tarrant County history. The photographs are a mix of original and copy prints of various sizes including oversize and panoramic. Examples of topics covered include street scenes and storefronts, businesses, community organizations, military bases, and more.

**3. *Collection of mixed materials relating to Texas and Tarrant County history, donated by Dalton Hoffman. (2023-050-503)***

Materials donated relate to the history of Pastor J. Frank Norris and the First Baptist Church; street and railway maps and travel guides; property abstracts; Southwestern Livestock Show and Rodeo; Robbins and Kelly Endurance Flight; Texas Sesquicentennial; the JFK assassination; and more. These materials include about 150 original legal documents, publications, documents, and ephemera.

**4. *Collection of materials related to Kennedale and Tarrant County history, donated by the Kennedale Historical Society. (2024-001-033)***

Materials donated include newspapers and clippings describing events in Kennedale history, ephemera and documents related to local businesses and events, and publications created by local entities and organizations reporting on various aspects of the area.

**5. *Twenty-seven (27) boxes of records, donated by the Tarrant County Clerk's Office. (2024-002-174)***

Materials donated by the Tarrant County Clerk's Office are boxes of items that were previously stored in the Archives, but ownership was retained by the County Clerk. These materials were transferred to the Archives in 2010 for storage. The County Clerk and Archives came to an agreement that they should officially be donated. Materials included were created between 1877 and 1980, and contain reports, legal documents, and records of various kinds related to schools, finances, property ownership, infrastructure, courts, elections, and more.

**6. *Two (2) photographs, donated by Earl Manning. (2024-003-067)***

Two photographs are from the early 1900s, showing a woman and children on the porch of a house. The house is possibly 2210 Stanley Ave, Fort Worth. Photographs of old homes are difficult to find but are a common request in the Archives. They are often used as a reference for historic building renovations and for historic designation applications.

**7. *Series of photographs related to Tarrant County employees and events and Fort Worth history art print posters, donated by the Tarrant County Administration Department. (2024-004-171)***

Materials donated include physical photo prints, digital files of photographs on CDs, and numerous posters. The photographs are of employee events including the 100<sup>th</sup> Anniversary celebration of the Courthouse, annual employee picnic, staff headshots, and photos used for promotional materials. The posters include a series of art prints showing scenes of Fort Worth history.

**8. *Selection of materials related to Tarrant County history, donated by Gary and Floreen Barger Henry. (2024-005-073)***

Materials donated include six (6) editions of *The Eagle* yearbook from Riverside High School, two Parent-Teacher Association publications, a land abstract and related warranty deeds, other property documents, and a publication related to the USS Fort Worth.

**9. *Materials related to Kennedale history, donated by the Kennedale Historical Society. (2024-006-033)***

Materials donated include eleven (11) digital images related to Kennedale history from 1900 through the 1950s. These images show various landmarks of Kennedale as well as notable community members and school groups. One photograph of the Brown family also includes additional documentation identifying the individuals in the photograph. Also included in this donation is a scrapbook from the James A. Arthur Elementary School PTA for the 1967-1968 school year.

**10. *Fort Worth Frontier Centennial materials, donated by Dalton Hoffman. (2024-008-503)***

Hosted as a counter celebration to Texas's Official Centennial Celebration in Dallas, the Fort Worth Frontier Centennial was a time of great growth and celebration in Fort Worth. Items donated include newspaper clippings, photographs, and ephemera related to the celebration. Also included are two neckties and a pennant created for the celebration.

**11. *Maps and plans of Tarrant County buildings, donated by the Dell DeHay Law Library of Tarrant County (2024-010-074)***

Materials donated include a selection of architectural plans for Tarrant County buildings, specifically for renovations to the historic Courthouse and old Civil Courts building. Maps included in the donation show cities, school districts, and election precincts in Tarrant County. Some materials in this donation are for scan and return, and the Archives will retain only the digital files of the items.
