BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred seventy-four (174) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on December 11, 2023 was attended by one (1) vendor as well as representatives from the four (4) Maintenance Precincts and Purchasing. Six (6) bids were received.

Bids were evaluated by the four (4) Maintenance Precincts and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

There is no secondary award for Section 1, Item 35, because only one (1) bid was received. Pathmark Traffic Equipment, LLC elected not to have secondary award designation.

The contract is used by the four (4) Maintenance Precincts to provide traffic control devices, safety items, and signage for use during road construction in unincorporated areas of Tarrant County.

Therefore, it is the joint recommendation of the four (4) Maintenance Precincts and Purchasing that Bid No. F2024041, Annual Contract for Traffic Control Equipment, be awarded to the vendors listed above at the per unit price and discount from list price.

FISCAL IMPACT

Expenses for last year were approximately \$41,000.00. Orders are placed on an as-needed basis. Funding in the amount of \$82,893.96 is available in the following accounts:
