**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve Amendment No. 1 to the Program Year (PY) 2021 Continuum of Care (CoC) Subrecipient Agreement between Tarrant County and The Salvation Army for the SIMON Permanent Supportive Housing (PSH) Program, Grant #TX0447L6T012105.

**BACKGROUND**

In Fall 2021, Tarrant County, through the Community Development Division, in conjunction with the City of Fort Worth, City of Arlington and the Tarrant County Homeless Coalition (TCHC), applied for funding for the above-named project. The application was made in response to the U.S. Department of Housing and Urban Development's (HUD's) CoC Homeless Assistance Programs request for proposals.

This grant will provide The Salvation Army with the resources to assist forty (40) households experiencing homelessness. These services include rental assistance, transportation, and general case management. Tarrant County is the grant recipient.

On July 26, 2022, the Commissioners Court, through Court Order #138615, accepted funding for the above-named renewal project.

On September 20, 2022, the Commissioners Court, through Court Order #139153, approved the subrecipient contract between Tarrant County and The Salvation Army.

Approval of Amendment No. 1 will move funds from the Administrative budget to the Leasing budget at the request of the funded agency.
