KNOW ALL MEN BY THESE PRESENTS:

THAT, Gomez Floor Covering, Inc. dba GFC Contracting (hereinafter called the Principal), as principal, and SureTec Insurance Company, a corporation organized and existing under the laws of the State of Texas, licensed to do business in the State of Texas and admitted to write bonds, as surety, (hereinafter called the Surety), are held and firmly bound unto Tarrant County (hereinafter called the Oblige), in the amount of Seventy-One Thousand Eight Hundred Nineteen and 00/100----- Dollars (\$71,819.00) for the payment whereof, the said Principal and Surety bind themselves, and their heirs, administrators, executors, successors, and assigns, jointly and severally, firmly by these presents.
