**SUBJECT: APPROVAL OF TEMPORARY REASSIGNMENT OF SPACE AND  
BUILDING RENOVATIONS AT THE NORTHEAST ANNEX AND  
THE TARRANT COUNTY RESOURCE CONNECTION FOR THE  
LAW ENFORCEMENT TRAINING CENTER PROJECT**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court approve temporary reassignment of space and building renovations to the Northeast Annex and the Tarrant County Resource Connection (TCRC) for the Law Enforcement Training Center Project.

**BACKGROUND**

On November 21, 2023, the Commissioner Court was briefed on the latest updates regarding the Law Enforcement Training Center. As a result of the briefing, the Court instructed Facilities Management to move forward with the renovation of Building 1500 at the TCRC, which will serve as the new Law Enforcement Training Center.

To facilitate the renovation, the existing occupants in Building 1500, and occupants in other County buildings will need to be relocated to various County locations. Building 1500 is currently occupied by the Sheriff's Office Training Academy, the Tarrant Regional Auto Crimes Task Force, CSCD and the Public Health WIC Clinic.

The temporary space reassignment request provides adequate office and operational space for the following departments:

The Sheriff's Office Training Academy will relocate from Building 1500 to Level 2 of the Northeast Annex.

The Tarrant Regional Auto Crimes Task Force will relocate from Building 2400 at the TCRC to Level 2 of the Northeast Annex.

The Public Health Mobile Operations Division will relocate from Building 1400 at the TCRC to the east wing of Building 2400 at the TCRC.

The Public Health WIC Clinic will relocate from Building 1500 at the TCRC and will be reassigned to the west wing of Building 2500 at the TCRC. JPS has agreed to vacate 3,542 square feet of space in Building 2500 to accommodate the relocation of the WIC Clinic.

CSCD will relocate from Building 1500 to Building 1400 at the TCRC.

The scope of work at the various locations will consist of minor demolition, flooring, minor construction of walls, and rerouting of electrical/data service as needed. All spaces will be refreshed and make-ready for occupancy prior to the move in of the various departments.

### **FISCAL IMPACT**

The fiscal impact is \$25,865.00. Funding is available from funds designated for this project in account CARPA-2024.
