COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve the FY 2024 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part C (Part C) subrecipient contract renewal with CAN Community Health Inc. (CAN).

BACKGROUND

Tarrant County receives annual grant funding from HRSA to provide a variety of essential core and support services to HIV-positive individuals. Part C grant funding provides health care and support services in outpatient settings for people living with HIV in the Health Services Delivery Area (HSDA). HSDA includes the Fort Worth/Arlington Transitional Grant Area (TGA) which includes the counties of Tarrant, Wise, Johnson, Parker, Hood, Erath, Palo Pinto, and Somervell. Tarrant County HIV Administrative Agency (HIV-AA) administers grant funding through subcontracts with community organizations that deliver high-quality HIV services.

CAN Community Health is a not-for-profit organization that has served the needs of the HIV community for over thirty (30) years by providing comprehensive care involving the expertise of many different healthcare professionals to manage the multiple physical and emotional health problems of patients. CAN Community Health provides clients with medical care, dental care, counseling and therapy, HIV case management, education and peer support, and pharmacy services.

On December 19, 2023, the Commissioners Court, through Court Order #142299, accepted the FY 2024 Part C partial Notice of Award (NOA) in the amount of \$215,771.00. Final award for Part C will be processed as soon as HRSA receives the full FY 2024 appropriation.

The Part C project period is January 1, 2022 through December 31, 2024, and the term of the budget period is January 1, 2024 through December 31, 2024.

The recommended contract renewal is as follows:

CAN – Total reimbursement shall not exceed \$194,193.90.
