SUBJECT: RFP NO. F2024023 - ANNUAL CONTRACT FOR DISASTER DEBRIS REMOVAL, REDUCTION, DISPOSAL, AND OTHER EMERGENCY RELATED SERVICES - EMERGENCY MANAGEMENT - VARIOUS VENDORS - PER CONTRACT TERMS

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court award RFP No. F2024023, Annual Contract for Disaster Debris Removal, Reduction, Disposal, and Other Emergency Related Services, for Emergency Management, to the following vendors at the per contract terms:

Primary	DRC Emergency Services, LLC
Secondary	TFR Enterprises, Inc
Alternate	Ceres Environmental Services, Inc.

BACKGROUND

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred eighteen (118) vendors were contacted and requested to participate in this proposal process. All documents pertaining to this RFP were posted on the Tarrant County website and were downloaded by interested parties. A pre-proposal conference held on November 29, 2023 was attended by five (5) vendors as well as representatives from Emergency Management, Transportation Services, Budget & Risk Management, and Purchasing. Nine (9) proposals and four (4) no-bids were received.

Proposals were evaluated by Emergency Management, Transportation Services, Budget & Risk Management, and Purchasing representatives. Evaluations were based upon the criteria and processes set forth in the RFP. The proposals received from the vendors listed above meet all specifications and are acceptable to Emergency Management.

The term of the contract is twelve (12) months, effective March 13, 2024, with two (2) options for renewal periods of twelve (12) months each.

This contract is used for clearance, demolition, removal, reduction, and disposal of debris during a disaster event. Services provided include removal of debris, reduction of debris into smaller volumes, and the disposal of debris material.
