SUBJECT: APPROVAL OF AN INTERLOCAL AGREEMENT WITH THE CITY OF FORT WORTH RELATED TO THE WEST BONDS RANCH ROAD WIDENING AND WAGLEY ROBERTSON ROAD EXTENSION PROJECT - 2021 TRANSPORTATION BOND PROGRAM

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve an Interlocal Agreement (ILA) with the City of Fort Worth related to the West Bonds Ranch Road Widening and Wagley Robertson Road Extension project - 2021 Transportation Bond Program (TBP) located in Precinct 3.

BACKGROUND

On August 3, 2021, the Commissioners Court, through Court Order #136021, accepted a prioritized list of thirty-three (33) projects recommended by the participating cities and the Court-appointed Project Evaluation Committee (PEC) for funding in the Call for Projects (CFP) category of the 2021 TBP. The W. Bonds Ranch Road and Wagley Robertson Road Extension is included in the approved list of projects.

With voter approval of Proposition A on November 2, 2021, and with Commissioner Court approval of the issuance of bond funds on May 24, 2022, through Court Order #138185, the County is now proceeding with the execution of an ILA with the City of Fort Worth related to the W. Bonds Ranch Road and Wagley Robertson Road Extension project. This project will be funded through the 2021 TBP, CFP funding category.

This project consists of the construction (or reconstruction) of W. Bonds Ranch Road from Wagley Robertson Road to West of US 287 at the roundabout. This project will include approximately one (1) mile of a four (4) lane divided concrete urban arterial that includes curb and gutter, internal drainage, three (3) major creek crossings, an at-grade railroad crossing, streetlights, traffic signals, and shared use paths. The existing roundabout will be modified to a multi-lane roundabout at the US 287 Southbound frontage road. This project will also include extension improvements of about 350 feet of Wagley Robertson Road to the north and improvements to the south of W. Bonds Ranch Road.

This ILA has been reviewed by the Auditor's Office and approved as to form by the Criminal District Attorney's Office.
