SUBJECT: **PERMISSION TO TAKE BIDS/RFPs**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court grant permission to take Bids/RFPs for the following:

a. Purchase of Striping Truck

Estimated Value - \$490,000.00

Funding is available in FY2024 budget.

The purpose of this contract is for road striping projects on County and city roads through Interlocal Agreements. The current striping truck frequently requires repairs making it difficult for the striping crew to maintain a consistent schedule and meet striping deadlines. This will be purchased by Transportation Services and the primary contact is Randy Skinner, Director.

b. RFP for Plaza Building Garage Expansion

Estimated Value - \$7,854,000.00

Funding is available in FY2024 budget.

The purpose of this contract is the addition of an eight-level parking bay of 104,719 square feet to extend the existing parking garage by 293 additional parking spaces. This project will be facilitated by Facilities Management and the primary contact is Michael Amador, Director.

c. RFP for Annual Contract for Officer Candidate Examination and Assessment Services

Estimated Value - \$49,000.00

Funding is available in FY2024 budget.

The purpose of this contract is to provide Officer Candidate Examination and Assessment Services to assist in promotion of qualified candidates. The project will include the creation of examination questions and assessment exercises that will aid in the promotion process. This contract will be used by the Sheriff's Office and the primary contact is Captain Milton Kuser.

d. RFP for Annual Contract for Broker of Record

Estimated Value - \$75,000.00

Funding is available in FY2024 budget.

The purpose of this contract is to obtain an agent who will advise the County in the evaluation of current County insurance policies, as well as recommend and negotiate rates and terms for potential replacement policies, according to what is in the best interest of the County. This contract will be used by Budget and Risk Management and the primary contact is Travis Yarbrough.

e. RFQ for Annual Contract for Tissue Bank Services

Estimated Value - This award constitutes revenue to Tarrant County

The purpose of this contract is to utilize a qualified organization to provide tissue bank services to obtain cadaver tissue from donors that are in the custody of the Tarrant County Medical Examiner. The selected organization shall be responsible for contacting the next of kin of the deceased and offering the service for tissue donation as defined in the Texas Health and Safety Code Section 693.002. This contract will be used by Medical Examiner's Office and the primary contact is Arshad Majid.

f. Purchase of Asbestos Abatement Services for Resource Connection Isolation Valve Replacement

Estimated Value - \$600,000.00

Funding is available in FY2024 budget.

The purpose of this contract is to provide asbestos abatement services for asbestos containing pipes that must be disturbed during the replacement of isolation valves at the Resource Connection. This contract will be used by Facilities Management and the primary contact is Michael Amador, Director.
