SUBJECT: CONSIDERATION OF PROGRAM YEAR 2023 CONTINUUM OF CARE GRANT SUBRECIPIENT AGREEMENT BETWEEN TARRANT COUNTY AND TARRANT COUNTY SAMARITAN HOUSE, INC. FOR THE GRACE VILLAGE PERMANENT SUPPORTIVE HOUSING PROGRAM

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court consider Program Year (PY) 2023 Continuum of Care (CoC) Subrecipient Agreement between Tarrant County and Tarrant County Samaritan House, Inc. for the Grace Village Permanent Supportive Housing (PSH) Program, Grant #TX0259L6T012312.

BACKGROUND

In Fall 2023, Tarrant County, through the Community Development Department, in conjunction with the City of Fort Worth, City of Arlington, and the Tarrant County Homeless Coalition, applied for funding to support homeless assistance projects. The application was submitted in response to a request for proposals from HUD’s CoC Homeless Assistance Program.

On August 20, 2024, the Commissioners Court, through Court Order #143658, approved the FY 2023 CoC Program Grant Agreement with HUD to provide Tarrant County with \$132,957.00 in grant funding to support the Grace Village PSH Program. Tarrant County retains fifty percent (50%) of the \$10,825.00 Administrative Costs allowance within the grant budget.

With approval, Tarrant County will reimburse Tarrant County Samaritan House, Inc. for providing services to six (6) households experiencing homelessness through the Grace Village Program. Reimbursement will not exceed the following amounts:

Supportive Services	\$ 20,900.00
Rental Assistance	\$101,232.00
Administrative Costs	<u>\$ 5,412.50</u>
Total	\$127,544.50

The agreement shall be for a term of twelve (12) months, commencing on December 1, 2024 and terminating on November 30, 2025.
