It is requested that the Commissioners Court approve renewal of RFP No. 2022-137A, Annual Contract for Offender/Defendant-Paid Batterer's Intervention and Prevention Program and High-Risk Batterer's Intervention and Prevention Program, for the first optional twelve (12) month period at the same contract terms.

BACKGROUND

On September 6, 2022, the Commissioners Court, through Court Order #139052, awarded RFP No. 2022-137A, Annual Contract for Offender/Defendant-Paid Batterer's Intervention and Prevention Program and High-Risk Batterer's Intervention and Prevention Program, for Community Supervision and Corrections Department (CSCD) to the following vendors:

The awards were based upon evaluation criteria set forth in the RFP specifications and contained options to renew for three (3) additional twelve (12) month periods.

CSCD utilizes the Batterer's Intervention and Prevention Program and High-Risk Batterer's Intervention and Prevention Program as supervision tools for defendants and as alternative measures for sentencing, confinement, and possible revocation.

The vendors notified Purchasing in writing that they will extend the same contract terms through June 30, 2025. CSCD notified Purchasing in writing they are pleased with the vendors and want to renew.
