COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court approve renewal of Bid No. 2023-149, Annual Contract for Traffic Paint, for the first and final optional twelve (12) month renewal period at the same firm fixed prices and acknowledgement of notification of acquisitions and vendor name changes.

BACKGROUND

On July 18, 2023, the Commissioners Court, through Court Order #141290, awarded Bid No. 2023-149, Annual Contract for Traffic Paint, for Transportation Services, to the following vendors at the per unit price:

Primary	LBS Enterprises, LLC d/b/a Allstates Coatings Company
Secondary	RoadSafe Traffic Systems, Inc. (formerly Dobie Supply, LLC)
Alternate	Ingevity (formerly Ozark Materials, LLC)

The awards were based upon low bid meeting specifications and contained an option to renew for one (1) additional twelve (12) month period.

Traffic paint is used for marking on roads, as well as garage entrances, car parking lots, and buildings. It is designed to adhere to asphalt, concrete, and cement and to withstand demanding weather conditions and wear and tear.

The vendors notified Purchasing in writing that their prices will remain firm through August 26, 2025. Transportation Services notified Purchasing in writing that they are pleased with the vendors and want to renew.

In an attached letter dated June 27, 2024, the secondary vendor notified Purchasing in writing of the acquisition and vendor name change from Dobie Supply, LLC to RoadSafe Traffic Systems, Inc. and that RoadSafe Traffic Systems, Inc. will honor all pricing and terms and conditions in the original contract.

Additionally, in an attached letter dated June 27, 2024, the alternate vendor notified Purchasing in writing of the acquisition and vendor name change from Ozark Materials, LLC to Ingevity, and that Ingevity will honor all pricing and terms and conditions in the original contract.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that the Commissioners Court approve renewal of Bid No. 2023-149, Annual Contract for Traffic Paint, for another twelve (12) month period.

FISCAL IMPACT
