BACKGROUND

Notice of the County’s intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred seventy-one (171) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on November 29, 2023 was attended by one (1) vendor as well as representatives from Purchasing. Eleven (11) bids and three (3) no-bids were received.

Bids were evaluated by Facilities Management and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Uncharted Territory Solutions withdrew their bid for items 10 and 12 due to pricing errors.

The term of the contract is twelve (12) months, effective February 4, 2024.

This contract is used to ensure consistent supply and functionality of AED units and bleed control kits for County buildings.

Therefore, it is the joint recommendation of Facilities Management and Purchasing that Bid No. F2024036, Annual Contract for Automated External Defibrillators (AED's), Accessories, and Bleed Control Kits, be awarded to the vendors listed above at the per unit price.

FISCAL IMPACT

Expenses for last year were approximately \$70,000.00. The County's future cost will be determined by the orders placed on an as-needed basis. Funding is available in account 10000-2024 General Fund/Various Cost Centers/532011 Building Maintenance.
