**COUNTY OF TARRANT   §**     **Renewal and Amendment No. 1 to the Interlocal Agreement for Wichita Street Widening Project**

**BACKGROUND**

1. Tarrant County (“COUNTY”) and the City of Forest Hill (“CITY”) entered into an Interlocal Agreement (ILA) approved by Tarrant County Commissioners Court Order No. 139976 for financial support of up to \$11,110,000, for the cooperative funding of improvements to Wichita Street Widening (“Project”) as described in the 2021 Tarrant County Transportation Bond Program.
2. An amendment to the 2021 Transportation Bond Program (TBP), Countywide Initiatives and Partnership Category, was authorized on September 5, 2023, by Tarrant County Commissioners Court, Court Order No. 141673 authorizing an increase of the COUNTY’s funding share by \$2,500,000.
3. The COUNTY and CITY desire to renew and amend this ILA to provide financial support of up to \$13,610,000 in 2021 TBP Countywide Initiatives and Partnership funds to cover the higher than estimated construction costs for the construction phase of this Project.
4. The Project is incomplete and the parties desire to renew the Interlocal Agreement for the 2024 Fiscal Year.

Therefore, the COUNTY and CITY agree to the following:

1. The COUNTY and the CITY renew the Interlocal Agreement for the COUNTY’s 2024 Fiscal Year, with the Interlocal Agreement expiring September 30, 2024, or upon completion of the Project as determined by the COUNTY, whichever occurs sooner.
2. The COUNTY and CITY agree to the revised Payment Schedule in Attachment A.
3. All terms and conditions of the original Interlocal Agreement and subsequent amendments remain in effect except to the extent modified by this Renewal and Amendment No 1.


