**SUBJECT: PUBLIC HEARING - TO CONSIDER AMENDMENT NO. 10 TO THE
PROGRAM YEAR 2020 ACTION PLAN - COMMUNITY
DEVELOPMENT**

COMMISSIONERS COURT ACTION REQUESTED

It is requested that the Commissioners Court conduct a public hearing to consider Amendment No. 10 to the PY 2020 Action Plan regarding Community Development Block Grant – CARES Act (CDBG-CV) funds.

BACKGROUND

On May 5, 2020, the Commissioners Court, through Court Order #132721, approved the five (5) year Consolidated Plan, which included the 2020 Action Plan.

Public Comments will be received regarding Amendment No. 10 to the 2020 Action Plan. This substantial amendment includes adding two (2) CDBG-CV funded water improvement projects as follows:

City of Forest Hill

\$197,389.00

This project consists of replacing 595 linear feet of existing 6" ductile iron water lines with 8" PVC water lines on the north side of Woodbridge Drive between Folkstone Drive to Lee Street.

City of Watauga

\$374,875.00

This project consists of replacing 770 linear feet of 6" cast iron with 8" DR-18 PVC water line along the east side of Plum Street between Shipp Drive and Bowie Street.

In addition, the CDBG-CV funded City of Hurst Water Improvement Project will be amended to increase funding from \$200,000.00 to \$240,000.00. This project aims to mitigate multiple system failures which will help maintain safety and hygienic practices.

Per 24 CFR § 91.105(a)(3), Tarrant County must provide citizens with a reasonable opportunity to comment on substantial amendments. Tarrant County's citizen participation policy for amending the Action Plan occurs when the funding amount, location, or beneficiaries of a project proposed under the plan are changed, or the scope of the project is increased or reduced by more than twenty-five percent (25%), Tarrant County shall amend its plan. Public comment will be received October 2, 2023, through the end of today's public hearing.
