### **BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred eighty-five (185) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. No vendors attended the pre-bid conference held on May 1, 2024. Eight (8) bids were received.

Bids were evaluated by Transportation Services and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

The purpose of this bid is to purchase full-size half ton crew cab SWB pickup trucks for the Sheriff's Office, the four (4) Maintenance Precincts, and Transportation Services.

Therefore, it is the joint recommendation of Transportation Services and Purchasing that Bid No. F2024113, Purchase of Full-Size Half Ton Crew Cab SWB Pickup Trucks, be awarded to the vendors listed above at the per unit price. Orders will be placed with awarded vendors based on availability and price.
