SUBJECT: BID NO. 2021-138 - ANNUAL CONTRACT FOR TRASH REMOVAL SERVICES - FACILITIES MANAGEMENT - ALLIED WASTE SERVICES OF FORT WORTH, LLC, D/B/A REPUBLIC SERVICES OF FORT WORTH - PER UNIT PRICE

COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court rescind Court Order #136504 for Bid No. 2021-138, Annual Contract for Trash Removal Services, for Facilities Management, and approve award to Allied Waste Services of Fort Worth, LLC, d/b/a Republic Services of Fort Worth at the per unit price.

BACKGROUND:

On September 28, 2021, the Commissioners Court, through Court Order #136504, awarded Bid No. 2021-138, Annual Contract for Trash Removal Services, Inc., for Facilities Management, to Allied Waste Services of Fort Worth, LLC d/b/a Republic Services of Fort Worth, at the per unit price.

After the award was made, it was realized that the bid tabulation had a per week pricing list rather than the per month pricing that was originally submitted by the vendor. An updated bid tabulation is attached.

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Fifty-two (52) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on July 28, 2021 was attended by two (2) vendors as well as representatives from Facilities Management and Purchasing. One (1) bid was received.

The bid received from Allied Waste Services of Fort Worth, LLC, d/b/a Republic Waste Services of Fort Worth meets all specifications and is acceptable to Facilities Management.

The term of the contract is twelve (12) months, effective October 1, 2021, with two (2) options for renewal periods of twelve (12) months each.
