BACKGROUND:

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Four hundred twenty-eight (428) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. Fifty-eight (58) bids and one (1) no-bid were received.

Bids were evaluated by Public Health and Purchasing representatives. Award recommendations are to the low bids meeting specifications.

Lex Industries and Great Hawk Air Service were deemed non-responsive for failure to provide required signatures. Globalgeeks, Inc. did not meet specifications for item 4, USA Medical Supply for items 1, 2, 5, and 6, and US Health Express Group d/b/a Jointown International for item 6 because each vendor failed to provide samples upon request as required. The bids received from Lainere Health and Wellness, US Health Express, LCCS Medical, Reveal Medical, United States Mask, LLC, Just in Trend, Front Line Crossings Medical Supplies, Clark Collection, Krish Ventures, LLC, Mini Wing USA, Linstol USA, LLC, and HSM Med Supply did not meet specifications because they bid alternate items despite clear instructions that only the items requested would be accepted.

The term of the contract is twelve (12) months, effective January 12, 2021, with one (1) option for a renewal period of twelve (12) months.

Therefore, it is the joint recommendation of Public Health and Purchasing that Bid No. 2021-030, Annual Contract for N95 and KN95 Masks, be awarded to the vendors listed above at the per unit price.

FISCAL IMPACT:

Annual expenses are estimated to be approximately \$810,000.00. Orders are placed on an as-needed basis.
