### **COMMISSIONERS COURT ACTION REQUESTED:**

It is requested that the Commissioners Court approve Amendment No. 3 to one (1) FY 2020 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part C subrecipient contract with Tarrant County Hospital District.

### **BACKGROUND:**

On December 10, 2019, the Commissioners Court, through Court Order #131751, approved the acceptance of the FY 2020 Ryan White Part C Notice of Award for HIV/AIDS services in the amount of \$201,301.00.

On February 4, 2020, the Commissioners Court, through Court Order #132054, approved the FY 2020 HRSA Ryan White Treatment Extension Act Part C subrecipient contract renewals with AIDS Healthcare Foundation, Tarrant County Hospital District, and Tarrant County Preventive Medicine Clinic.

On April 28, 2020, the Commissioners Court, through Court Order #132667, approved Amendment No. 1 of the HRSA FY 2020 Ryan White Part C Notice of Award for the Ryan White Part C grant contract renewal in the amount of \$603,904.00.

On May 12, 2020, the Commissioners Court, through Court Order #132777, approved Amendment No. 1 to the FY 2020-2021 HRSA Ryan White Treatment Extension Act Part C subrecipient contracts with AIDS Healthcare Foundation, AIDS Outreach Center, Tarrant County Hospital District and Tarrant County Preventive Medicine Clinic.

On November 3, 2020, the Commissioners Court, through Court Order #134134, approved Amendment No. 2 to the FY 2020-2021 HRSA Ryan White Treatment Extension Act Part C subrecipient contract with Tarrant County Hospital District.

The recommended contract amendment is as follows:

Tarrant County Hospital District – Total reimbursement shall not exceed \$221,148.00.
