COMMISSIONERS COURT ACTION REQUESTED:

It is requested that the Commissioners Court approve three (3) FY 2020-2021 Health Resources and Services Administration (HRSA) Ryan White Treatment Extension Act Part A subrecipient contract renewals with AIDS Outreach Center, Tarrant County Hospital District and Tarrant County Samaritan Housing, Inc.

BACKGROUND:

On February 25, 2020, the Commissioners Court, through Court Order #132223, approved the receipt of the Health Resources and Services Administration (HRSA) FY 2020-2021 Notice of Award for the Ryan White Part A grant contract renewal in the amount of \$979,447.00.

As part of the Tarrant County responsibility as administrative agency for this grant, a network of subrecipients is maintained to coordinate service levels and mixes within the community. AIDS Outreach Center, Tarrant County Hospital District and Tarrant County Samaritan Housing, Inc. are participating subrecipients.

The term of these community subrecipient contracts is March 1, 2020 through February 28, 2021.

The recommended contracts are as follows:

AIDS Outreach Center – Total reimbursement shall not exceed \$418,662.00

Tarrant County Hospital District – Total reimbursement shall not exceed \$236,124.00.

Tarrant County Samaritan Housing, Inc. – Total reimbursement shall not exceed \$2,034.00.
