RE: Amendment No. 1 to 2020 Emergency Solutions Grant Program – CV Contract Signed on November 10, 2020 (Commissioners Court Order No. 134191)

Dear Ms. Wach:

On November 10, 2020, Tarrant County and **The Salvation Army** entered into the above-referenced contract (the "Contract"). By notice of this letter, Tarrant County proposes to amend the Contract concerning the following terms contained within the **Scope of Services** as follows:

11. SCOPE OF SERVICES

From the proceeds awarded to the County under the Emergency Solutions Grant Program (the "Grant"), the County will reimburse the Agency a budgeted amount for providing emergency shelter for the homeless in response to the COVID-19 pandemic. The County will reimburse The Agency for emergency shelter facility operating expenses. Eligible expenses include increased utilities and supplies and janitorial staff/services for COVID-19 temporary non-medical service delivery at an emergency homeless shelter.

Approved Budget: The total project budget for Emergency Solutions Grant Program # E-20-UW-48-0001-CV is \$844,131. The County, upon submission of written requests from the Agency, will reimburse the Agency out of the total project budget for allowable expenditures up to, but not exceeding, the following specified amounts:

Emergency Shelter Supportive Services Expenses \$232,206.00

The County will reimburse the Agency for this service upon timely submission of a monthly statement of expenditures. The County will only reimburse the Agency under this grant for approved eligible expenses as defined by 24 CFR Part 576 and 42 USC § 11375. The County will not reimburse the Agency for ineligible expenses or expenses incurred in excess of the maximum reimbursement amount under the total project budget.

Match Requirement: The ESG-CV program requires no match.

This portion of the Contract is hereby amended, at your request, as follows:

11. SCOPE OF SERVICES

From the proceeds awarded to the County under the **Emergency Solutions Grant Program** (the "Grant"), the County will reimburse the Agency a budgeted amount for providing emergency shelter for the homeless in response to the COVID-19 pandemic. The County will reimburse The Agency for emergency shelter facility operating expenses. Eligible expenses include increased utilities and supplies for COVID-19 temporary non-medical service delivery at an emergency homeless shelter, in addition to shelter operation expenses for COVID-19 isolation.

Approved Budget: The total project budget for Emergency Solutions Grant Program # E-20-UW-48-0001-CV is \$3,578,786.00. The County, upon submission of written requests from the Agency, will reimburse the Agency out of the total project budget for allowable expenditures up to, but not exceeding, the following specified amounts:

Emergency Shelter COVID Operations Expenses	\$412,206.00

The County will reimburse the Agency for this service upon timely submission of a monthly statement of expenditures. The County will only reimburse the Agency under this grant for approved eligible expenses as defined by 24 CFR Part 576 and 42 USC § 11375. The County will not reimburse the Agency for ineligible expenses or expenses incurred in excess of the maximum reimbursement amount under the total project budget.

Match Requirement: The ESG-CV program requires no match.

Tarrant County proposes to amend the Contract concerning the following terms contained within the **Term of Agreement** as follows:

VI. TERM OF AGREEMENT

This Agreement shall be for a term of twenty-six (26) months, commencing on March 1, 2020 and terminating April 1, 2022.
