(Commissioners Court Order No.135511)

Dear Ms. Wach:

On May 25, 2021, Tarrant County and **The Salvation Army** entered into the above-referenced contract (the "Contract"). On July 20, 2021, Tarrant County amended the Term of Agreement section of the Contract. On February 8, 2022, Tarrant County additionally amended the Term of Agreement section of the Contract. By notice of this letter, Tarrant County proposes to further amend the Contract concerning the following terms contained within the **Term of Agreement** as follows:

**SCOPE OF SERVICES**

Agency shall provide eligible services at the levels agreed upon in the current HUD approved Grant Application to the homeless population within Tarrant County during the term of this agreement.

Approved Budget: The total one-year project budget for the 2020 Continuum of Care Program TBLA 114 (#TX0113L6T012013) Grant is \$1,267,658. Tarrant County will reimburse Agency out of the project budget for the following expenditures, but not to exceed the following total amounts:

<b>Rental Assistance</b>	<b><u>\$ 302,950</u></b>
<b>Total</b>	<b>\$ 312,368</b>

Tarrant County will reimburse Agency for these services upon timely submission of monthly statement of expenditures. Tarrant County will not reimburse Agency under this grant for any expenses incurred in excess of the maximum reimbursement.

This portion of the Contract is hereby amended, at your request, as follows:

### **SCOPE OF SERVICES**

Agency shall provide eligible services at the levels agreed upon in the current HUD approved Grant Application to the homeless population within Tarrant County during the term of this agreement.

Approved Budget: The total one-year project budget for the 2020 Continuum of Care Program TBLA 114 (#TX0113L6T012013) Grant is \$1,267,658. Tarrant County will reimburse Agency out of the project budget for the following expenditures, but not to exceed the following total amounts:


