Re: Auditor's Report – Cash Counts of the Tarrant County Tax Offices


In accordance with Local Government Code, the Auditor's Office conducted surprise cash counts at all eight Tarrant County Tax Office locations on March 31, 2022. The objectives of our review were to determine whether:

- Change funds and remittances were accurately recorded and properly reconciled to the respective accounts;
- Change funds were used only to make change in connection with collections payable to the County and were not used to make loans, advances, or to cash checks or warrants of any kind; and
- Physical safeguards were in place to protect County funds.

Of the eight Tax Office locations, three locations had immaterial differences of \$10 or less that will be recorded to their Over/(Short) general ledger account. A fourth location was short \$100 because the clerk miscounted a cash receipt. Per the Tax Office Money Handling Policy, the shortage was paid by the clerk and deposited on April 1, 2022.
